Levy introduced the agenda item.


Discussion included: committee assignments; Eaton corner repair costs; and code of conduct revisions.

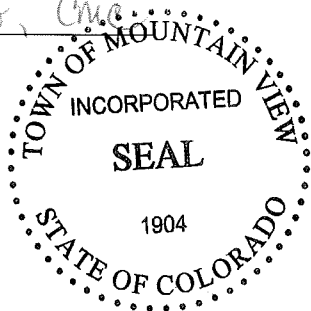


Councilmember Bailey moved to adjourn and Councilmember Davis seconded. All Aye. The Special Session meeting adjourned at 7:12 PM.
